# **Certification Policy Subcommittee Meeting Minutes**

February 1, 2024 10:00 a.m. By Zoom

#### 1. Call to Order

- At 10:01 a.m., Executive Director Zuniga welcomed the public to the Commission's first Subcommittee meeting and called the meeting to order.
- Executive Director Zuniga introduced the members of the Subcommittee: Commissioners Bluestone, Calderone and Kazarosian; as well as General Counsel Ravitz, Certification Director Smith and Outside Counsel Lon F. Povich.

## 2. Designation of the Chair - Enrique A. Zuniga

- Executive Director Zuniga offered a PowerPoint presentation providing background on the functions of the Chair, the process for scheduling future meetings, and public participation at future meetings, and he asked if any of the Commissioners would volunteer to serve as Chair.
- Commissioners Calderone and Kazarosian each volunteered to serve as Chair of the Subcommittee, leaving Commissioner Bluestone to select the Chair. Each Commissioner stated why they nominated themselves, and ultimately Commissioner Bluestone voted for Commissioner Calderone.

## 3. Purpose of the Subcommittee and discussion of policy questions - Enrique A. Zuniga

- Executive Director Zuniga continued his PowerPoint presentation, making the following points:
- The POST Commission created the Subcommittee to consider and advise on certain certification policy areas, notably the second round of certification of officers who have who have previously been certified by POST.
- All recommendations of the Subcommittee will be forwarded to the full Commission for consideration and approval, modification or rejection.
- The Subcommittee may request and consider public comment and/or participation of others at the discretion of the Chair of the Subcommittee.

- Executive Director Zuniga discussed the overall certification timeline and considerations as well as collaboration with the Municipal Police Training Committee (MPTC).
- Executive Director Zuniga provided an overview of the certification processes implemented thus far, the next round of certification and related issues, statutory certification standards and recertification policy questions.
- General Counsel Ravitz provided an overview of recertification policy questions regarding physical and psychological fitness evaluations, oral interviews, good moral character and fitness for employment, in-service training, and performance evaluations.
- Executive Director Zuniga ended the PowerPoint presentation by recommending topics for the next Subcommittee meeting, including the notification method regarding renewal of certification; background checks for self-sponsored applicants; questionnaires for self-sponsored applicants; and input from MPTC and others.
- Commissioner Bluestone discussed the efficiency of the process, and she said she would like to provide guidance to the Commission in a timely manner while examining the importance of the health and wellness of law enforcement officers across the Commonwealth and would like to include external parties in the conversation.
- Commissioner Calderone stated he would like to invite stakeholders to provide input at the next meeting.
- Commissioner Bluestone suggested the Subcommittee also invite external stakeholders.
- Commissioner Kazarosian also agreed that stakeholders should be invited to participate.
- Chair Calderone recommended that the Subcommittee members review the materials presented at the meeting and determine who they should invite to provide comments at the next meeting to be scheduled soon.
- Chair Calderone made a motion to adjourn the meeting and took a roll call vote on the motion. The Subcommittee voted as follows.
  - o Commissioner Bluestone Yes
  - o Commissioner Kazarosian Yes
  - o Commissioner Calderone Yes
- The motion was unanimously carried, and the meeting was adjourned.
